1. WELCOME AND INTRODUCTION

RCA Chair Cr Kylie King – Mayor, Albury City Council, opened the meeting and welcomed members to the meeting.

2. CONFIRMATION OF MEETING MINUTES

RCA Chair Cr Kylie King – Mayor, Albury City Council, tabled the draft minutes from the previous August 2022 meeting.

Ms Rachael Sweeney – RCA Secretariat provided an update on the actions from the RCA August Board Meeting. Members received and noted the minutes and updates.

5. REGIONAL CAPITALS AUSTRALIA POLICY

2022-23 Federal Budget Report

Ms Rachael Sweeney – RCA Secretariat tabled the 2022-23 Federal Budget Report for discussion and noting.

Ms Rachael Sweeney – RCA Secretariat provided an overview of the 2022-23 Federal Budget measures and noted there was an opportunity for RCA to provide input to the development of guidelines for the Growing Regions Program and the Regional Precincts and Partnership Program.

Members noted the 2022-23 Federal Budget Report.

RCA Draft Federal Funding Position Paper

Ms Rachael Sweeney – RCA Secretariat tabled the RCA Draft Federal Funding Position Paper for discussion and feedback.

Ms Rachael Sweeney – RCA Secretariat provided an overview of the paper and outlined the recommendations for members' information. Members noted the opportunity to engage with The Hon Catherine King MP - Minister for Infrastructure, Transport, Regional Development and Local Government on regional funding guidelines.

Members agreed to review the RCA Draft Federal Funding Position Paper and provide feedback on the document by 29 November 2022.

Cr Kellie O'Callaghan - Mayor, Latrobe City Council moved to endorse the RCA Draft Federal Funding Position Paper, noting members will provide any feedback on the full document. Mayor Jaysen de San Miguel – Mayor, City of Bunbury seconded.

6. GENERAL BUSINESS

Regional Funding

Mr Ken Diehm – CEO, Fraser Coast Regional Council noted infrastructure projects costs are fast exceeding the original estimates provided in federal grants due to the rising cost of materials and the strain on resources.

Members discussed writing to the Federal Government to extend support to existing infrastructure projects impacted by rising costs across all RCA members.



Members agreed to provide RCA Secretariat case studies of infrastructure projects where costs have exceeded the original estimates. Members agreed to write to relevant Ministers in support of additional funding for infrastructure commitments to address the increased cost of materials and labour.

RCA Chair Cr Kylie King – Mayor, Albury City Council noted consensus from members on the agreed action.

Members received the Draft RCA 2022 Meeting Schedule noting the Schedule will be reviewed once the 2023 Federal Sitting Calendar and ALGA National General Assembly dates are released.

Members noted ALGA National General Assembly presented an ability to gather RCA's membership in Canberra, however agreed a delegation would be unnecessary. Members agreed a Board Meeting would be held in June coinciding with the ALGA National General Assembly – however a delegation will not take place.

RCA Chair Cr Kylie King – Mayor, Albury City Council noted consensus from members on the Draft RCA 2023 Meeting Schedule, noting the calendar will be reviewed once the Federal Sitting Calendar is released.
