I am pleased to present our 2022 Annual Statement that highlights the important work of Regional Capitals Australia (RCA) as well as the many opportunities that lie ahead for our member cities.

A new era is dawning for regional Australia, with a 200% increase in net growth to regional areas during the past two years of the COVID-19 pandemic according to Infrastructure Australia research.

With remote working more widely accepted, Australia's regional capitals are now recognised as a viable alternative to metro cities – offering liveability, affordability and career opportunities.

RCA will continue to work hard to advocate our case for infrastructure, housing and skilled labour so the population boom is backed up by the right investment for sustainable growth.

This year saw the election of a new Federal Government and with that comes a fresh opportunity for a new regional agenda for the 8 million people who rely on regional capitals for their everyday needs.

The RCA Executive Board and Secretariat have worked to develop a strong policy and advocacy platform on behalf of our members in this busy election year, and I thank them for their efforts.

I would like to express my sincere appreciation to all of our member councils for their continued support, advocacy and commitment to the common goals and growth of regional capitals.

Our organisation is continuing to work closely with both sides of politics, our partners and relevant peak bodies to ensure that regional development is a top priority at the highest levels of government.

It has been a privilege to serve regional Australia during my tenure as Chair, and I look forward to supporting RCA's journey in the years ahead.

Key Activities and Achievements

Regional Capitals Australia continued to juggle a busy meeting schedule, despite the challenges of the COVID-19 pandemic that persisted in the first quarter of the year and the caretaker mode in the lead up to the federal election.

This year delivered a new Federal Government as well as two federal budgets in May and October which meant a particularly busy advocacy program.

Notable successes include additional funding for regional connectivity, an extension of the Local Roads and Community Infrastructure Program, an increase in the migration cap and two new regional funding programs totalling \$1 billion.

These important investments are essential for the long-term future and viability of the regions as a place to live and work. The following areas were a key focus of RCA's advocacy:

Regional Initiatives

- **Regional Development Funding:** The Federal Government has developed two new regional funding programs totalling \$1 billion, the Growing Regions Program and the regional Precincts and Partnerships Program
- **Local Roads and Community Infrastructure Program:** The Federal Government has committed to extend the Local Roads and Community Infrastructure Program with an additional \$250 million.
- **Digital Connectivity:** The Albanese Government's \$1.1 billion Better Connectivity for Rural and Regional Australia plan promises \$480 million to boost NBN speeds, conduct a national audit of mobile coverage, \$400 million to boost mobile coverage on roads, \$200 million toward place-based regional telecommunications and \$30 million to improve on-farm connectivity

- **Regional Housing:** The Housing Australia Future Fund will build social and affordable housing in regional Australia, and the Regional First Home Buyer Guarantee will help 10,000 families per year in regional areas to buy their first home.
- **Migration:** The Federal Government committed to increase the migration cap to 195,000 including an increase of 9,000 places for the regions and additional staff hired to process the visa application backlog of more than 900,000 applicants.

Regional Funding Programs

With the cessation of the Building Better Regions Fund, RCA has advocated strongly that growing regional cities need a reliable funding stream for investments in important community infrastructure. We conducted a survey of our members to help inform the guidelines for new funding programs and will continue to work closely with the Federal Government on the design and development.

The 2022 Federal Budget allocated \$1 billion to two new regional programs:

1. **Growing Regions Program:** new opportunities for regional local councils and not-for-profit organisations through an annual open, competitive grants process; and
2. **Regional Precincts and Partnerships Program:** to support community and place-based investment in rural and regional Australia, through both a competitive grants program and collaborative partnerships program.

It has also been announced that funding will be honoured for the existing City and Regional Deals.

Regional Digital Connectivity

RCA worked hard to advocate for an improved digital network for regional Australians. The Albanese Government's Better Connectivity for Rural and Regional Australia plan outlines:

- \$480 million to boost NBN speeds,
- A national audit of mobile coverage,

- \$400 million to boost mobile coverage on roads,
- \$200 million toward place-based regional telecommunications; and
- \$30 million to improve on-farm connectivity.

In the 2022 budget the following commitments were made:

- **NBN Upgrades:** 660 extra homes in regional Australia will receive full fibre upgrades;
- **Mobile Base Stations:** \$400 million (over 5 years from 2022-23) to support the roll out of mobile base stations to improve highway and underserved community mobile coverage;
- **Regional Connectivity Program:** \$200 million (over 5 years from 2022-23) to fund the delivery of telecommunications infrastructure to improve digital connectivity in regional, rural and remote Australia; and
- **Mobile Black Spots Program:** \$40 million (over 3 years from 2022-23) to implement commitments for new mobile infrastructure to improve mobile coverage and reception quality across Australia.

Regional Roads

The advocacy undertaken by RCA has contributed to a significant Federal investment in Australia's extensive regional road network.

In addition to the local roads and community infrastructure program, additional funding has been allocated toward road safety programs throughout the regions.

Regional road networks connect regional communities, and this important infrastructure needs to be continually maintained and improved. The following funds were committed in the 2022 Federal Budget.

- **Local Roads and Community Infrastructure Fund:** \$250 million for Phase 4 of the Local Roads and Community Infrastructure Program to support local councils.
- **Road Safety Program:** \$3 billion (total nationwide) to continue through to mid-2025.

Regional Rail

The rail network is an integral part of connecting regional Australia both through freight capacity and passenger services. We have long advocated for greater investment in faster rail and were pleased to see an allocation of \$500 million for the High Speed Rail Authority in the 2022 Federal Budget.

Regional Skills and Industry

Regional Capitals Australia has called for an urgent focus on addressing the regional skill shortage crisis, with data showing that a third of Australia's job vacancies are in regional Australia. Regional job vacancies reached a record 91,000 advertised jobs in August 2022, with many regions experiencing double digit growth over the past year.

The Federal Government committed to increase the migration cap to 195,000 including an increase of 9,000 places for the regions and additional staff hired to process the visa application backlog of more than 900,000 applicants.

RCA has also championed the development of a national population plan that focuses on attracting and retaining people to live and work in the regions and will continue to work with all levels of government to boost regional economic opportunities.

RCA welcomed the following commitments to regional skills and industry in the 2022 Federal Budget:

- Powering the Regions Fund (from 2022–23) with \$1.9 billion allocated to assist industries, regional Australia and communities with the transition to net zero emissions.
- Vocational Education and Training: \$921.7 million (over 5 years from 2022–23) to address skills shortages including providing 480,000 fee-free Technical and Further Education (TAFE) and vocational education places in industries and regions with skills shortages.
- National Reconstruction Fund: \$15 billion to finance projects that expand our industrial base, diversify our economy, create sustainable, well-paid jobs, and grow our regional centres.

Regional Arts

RCA has been advocating for the regional arts industry to help enhance the liveability of regional cities, in addition to creating new tourism opportunities.

The Federal Government has commenced development of a National Cultural Policy, as a roadmap for Australia's arts and culture sector.

To help, we've done the heavy lifting and compared the major parties on the big issues that matter to regional capital cities.

In a welcome move, both parties have come out strong on digital connectivity with the Coalition committing \$1.3 billion and the ALP promising to invest \$1.1 billion to improve both coverage and connectivity in regional and rural Australia.

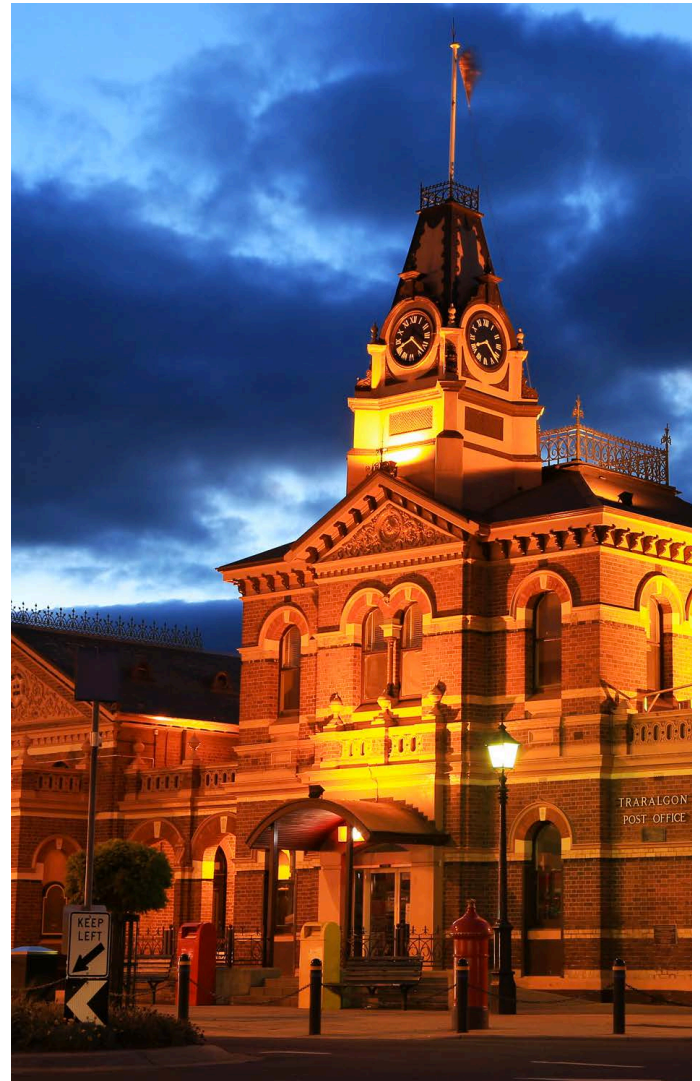
Strategic Relationships

RCA has continued to collaborate with key advocacy bodies that contribute to the development of regional capitals. We meet regularly with representatives from these organisations to discuss and implement the way forward for regional Australia.

- **Regional Australia Institute (RAI):** RCA has continued its collaborative efforts with the RAI to highlight the potential of regional capitals and our broader regions. RCA were pleased to take a key role in the RAI's Region's Rising Conference 2022 in Canberra, participating in a panel of keynote speakers discussing population growth. RCA also supported RAI's Regionalisation Ambition 2032 – A Framework to Rebalance the Nation by signing up to a pledge to support regional population growth.
- **Regional University Network (RUN):** RCA and RUN continue to advocate for opportunities to increase tertiary education access and attainment for those living outside of the major metropolitan cities.
- **National Farmers Federation (NFF):** RCA collaborated on joint calls for place-based investment into regional Australia, specifically the development of 20 regional development precincts. RCA attended and supported the launch of the NFF Regional Development Precincts Proposal, including advocacy with the Minister and follow-up media interviews. RCA also accepted a key role at the National Farmers Federation 2022 Conference, participating in a panel discussion on regional housing.

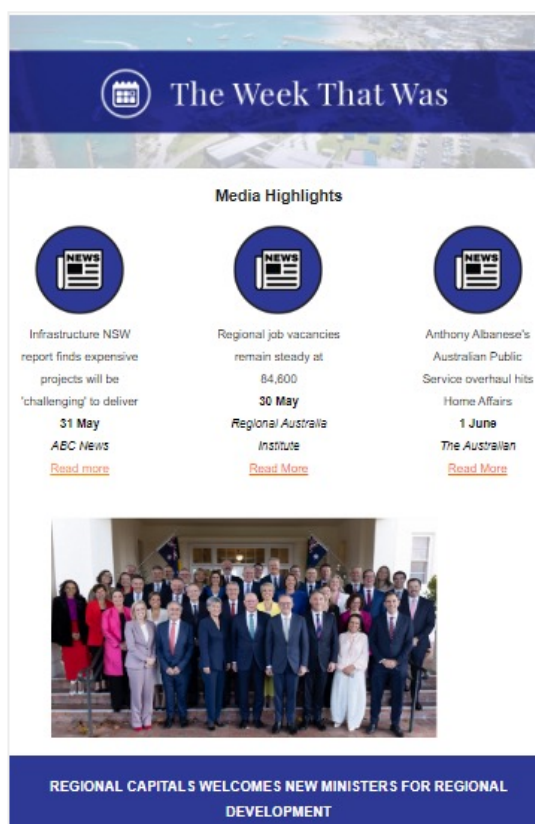

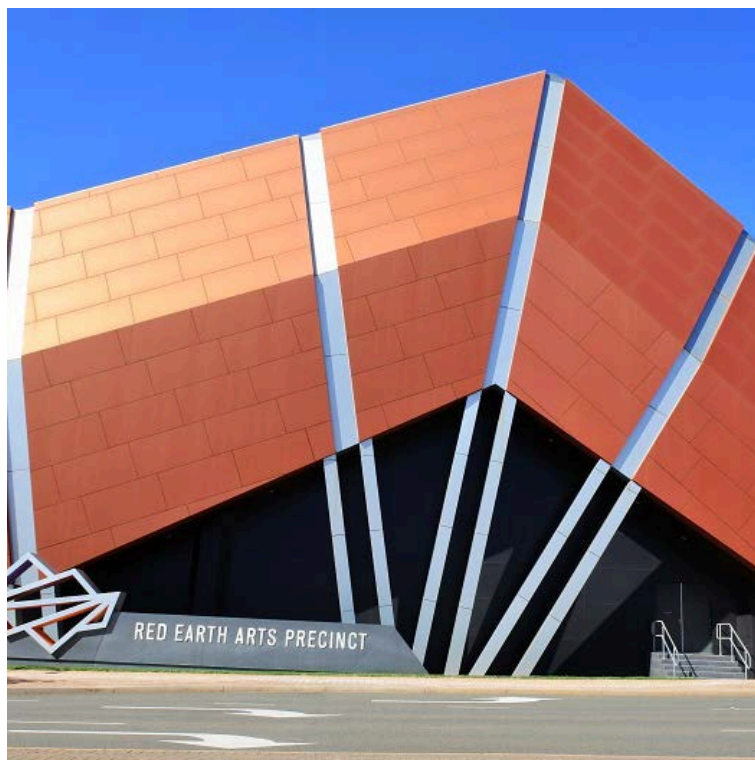

Regional Capitals Australia (RCA) has welcomed today's announcement by the Albanese Government that Australia's permanent migration cap will be increased, saying it is a welcome step for businesses currently struggling with crippling labour shortages.

RCA Chair and Mayor of Ballarat Cr Daniel Moloney said "We congratulate the Government on today's commitment to increase permanent migration, and thank them for listening to the collective voices of regional Australia."

Today at the Jobs and Skills Summit the Government announced that:

- Australia's permanent migration cap will be increased by 35,000 to 195,000 for this financial year;
- Regional Australia will have access to 34,000 permanent migrants, an increase of 9,000; and
- Post-study work rights for foreign graduates of Australian universities will also be increased by two years in areas of skills shortages.

A New Policy Agenda

Regional Capitals Australia has pressed the reset button on its policy agenda, emerging with a strong platform to further the economic and social development of regional capitals.

Given the new regional development agenda of the Albanese Government, RCA has re-shaped its key strategic priorities on which to engage the new government including:

- **Regional Infrastructure Policy:** advocating for long-term sustainable investment to meet the infrastructure needs of growing regions;
- **Connectivity:** including investment in road, rail, air and digital infrastructure to enhance regional connectivity;
- **Housing:** including social, key worker, infrastructure worker accommodation and the broader rental and general supply;
- **Economic Diversity:** ensuring the government's commitment to renewables provides the opportunity to diversify regional economies; and
- **Arts and Culture:** investing in the liveability and cultural diversity of our regions.

INDEPENDENT AUDITOR'S REPORT

TO THE MEMBERS OF

REGIONAL CAPITALS AUSTRALIA INC.

We have audited the accompanying financial report, being a special purpose financial report, of Regional Capitals Australia Inc. (the association) which comprises the committee's report, statement of financial position as at 30 June 2022 and the statement of profit or loss for the year then ended, notes comprising a summary of significant accounting policies and other explanatory notes.



Committee's Responsibility for the Financial Report

The committee of Regional Capitals Australia Inc. is responsible for the preparation and fair presentation of the financial report and has determined that the basis of preparation described in Note 1 is appropriate to meet the requirements of the *Associations Incorporation Reform Regulations 2012 (VIC)* and is appropriate to meet the needs of the members. The committee's responsibility also includes such internal control as the committee determines is necessary to enable the preparation and fair presentation of a financial report that is free of material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on the financial report based on our audit. We have conducted our audit in accordance with Australian Auditing Standards. Those standards require that we comply with relevant ethical requirements relating to audit engagements and plan and perform the audit to obtain reasonable assurance whether the financial report is free of material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial report. The procedures selected depend on the auditor's judgement, including the assessment of the risks or material misstatement of the financial report, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the association's preparation and fair presentation of the financial report, in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the association's internal control.
